

## **The300 2018 MEMBER PLEDGE AND WAIVER**

As a member of The300 I will need to raise funds to host the 4US Fun Fest events. My efforts will allow 100% of all the 4US Fun Fest registration fees, concessions sales, and donations to go towards ultrasound machines and training. 4US makes collecting donations by providing a fundraising page to receive tax-deductible donations online (safely & securely) from friends & family, and pre-written, editable donation appeals that can be sent from my page.

**FUNDRAISING.** The **minimum fundraising pledges** apply:

- 300 Member: \$300 (includes initial registration fee)
- Chaperone: \$200 (includes initial registration fee)
- Light Brigade: \$100 (includes initial registration fee)
- **NOTE: ½ of the minimum fundraising obligation is due by AUG 1.** Credit cards will be charged to achieve that amount if members have failed to raise 50% by that date.

**COMMITMENT TO SEEK HELP, IF NEEDED.**

- I will meet my minimum pledge requirement by NOV 30.
- If, by July 1<sup>st</sup> despite my best efforts, I believe I will fall short of my goal I will apply for a **very limited number of scholarships** from the Sponsor A Hero Fund.
- If I doubt my ability to raise funds at the outset – I will immediately notify 4US and apply for numerous sponsorship/scholarship/fundraising credit opportunities.

**VALUES:** I pledge to act in accordance with the **highest Christian morals and behavior.**

- I will treat all people, places, and property with love and respect.
- I will not possess or use any alcohol, tobacco or drugs.
- I will refrain from any behavior, clothing, or language that may be considered disruptive, obscene, profane or inappropriate.

### **Participant/Volunteer Waiver & Release from Liability**

*Ride4US, Inc. (aka 4US) covering The300, The 4US Fun Fest, The All in One Fun Run and World's Largest Squirr Gun Fight (Event).*

I enter into this Agreement in consideration of my participation in support of the Event on Wednesday August 8<sup>nd</sup>, Thursday August 9<sup>rd</sup>, Friday August 10<sup>th</sup> and/or Saturday August 11<sup>th</sup>, 2018.

1. I agree to assume all risks of injury, loss of life and damage to persons and property during the Event, and hereby release, discharge and hold harmless Ride4US, Inc., the Washington State Transportation Commission, the Washington State Department of Transportation and the Washington State patrol, any and all states, counties, cities through which such Event may occur, and all of the foregoing entities' agents, employees, officers, volunteers, sponsors, from all liabilities, claim, demands, causes of action, costs, losses, expenses or compensation of whatever nature for loss, damage or injuries to persons and/or property sustained by me, my heirs, personal representatives, successors and assigns and all other persons resulting from or in any way connected with the Event whether directly or indirectly caused or contribute to said injury, loss of life or damage to persons or property by their negligent acts, gross negligence or recklessness. I agree to indemnify Ride4US, Inc. for all damages, costs and attorney's fees in defending any action arising in any way from my participation in the Event.
2. I Release, Discharge and Covenant Not to Sue those entities named in this Agreement from all liability, claims, demands, or any other damages resulting from my participation in the Event. I agree that if I or any other person or entity makes a claim against any of said entities, I will indemnify and hold harmless each of said entities/individuals from any liabilities, damages, losses, expenses, attorney's fees, costs or any other damage incurred as a result of said claim.
3. I represent that I am in proper physical condition to participate in the Event. I authorize medical treatment for myself if such is needed and assume responsibility for all costs associated with such medical treatment and care.
4. I give Ride4US, Inc. Permission to use any images associated with the Event including but not limited to photographs and video footage for marketing and/or promotional purposes for any future Events and/or promotions.
5. If I am signing on behalf of a minor, I accept all responsibility associated with the minor's participation in the Event. Such responsibility includes but is not limited to any damages arising from or associated with the minor's participation such as medical expenses, economic and non-economic damages, damages to other participants, costs, attorney's fees and other expenses. If I am signing this Agreement on behalf of a minor, I agree that all above provisions apply to said minor. No minors under the age of 18 may participate as a volunteer in the Event without the express written permission (by way of signature on this agreement) of a legal parent or guardian. Ride4US in its sole discretion, and for any reason, reserves the right to remove any participant from the Event.
6. Any legal action brought as a result of or arising from my (or my minor child's) participation in the Event, shall be brought in Pierce County, Washington and shall be governed by the laws of the State of Washington.
7. The invalidity or unenforceability of any provisions in this Agreement shall not affect the other provisions thereof.
